## Code of Conduct

The purpose of the Code of Conduct is to establish guidelines for members at all MOMS Club functions or when interacting with other members. It will allow for the removal of members from the MOMS Club roster if they violate the guidelines established and set forth herein. The final decision will rest with the executive board.

### For the Kids

We all need to remember to focus on the behavior and not the individual. Each mother is responsible for her own child's behavior. We have to remember that there is no right or wrong way of parenting; we are not here to judge each other. When disciplining, please remove your child from the immediate area.

Aggressive behavior (hair pulling, hitting, kicking, biting, etc.) is not allowed. If any of these behaviors occur, please remove your child from the area. After a short time, your child can resume activity. If the behavior continues, please remove your child from the event for the day. If a child is consistently having behavior problems that have warranted their removal from several events, you may be asked to refrain from attending events until your child's behavior is under control. If a child is deemed a danger to themselves or other children on a continual basis, you may be asked to leave the MOMS Club with no refund of dues.

### For the Moms

1. No member shall use obscene language directed toward any member or their child/children.
2. No member shall use physical or obscene gestures toward any member or their child/children.
3. Members shall refrain from malicious gossip or harassment regarding other members of the club.
4. All members should be considerate and respectful.
5. Members shall not misuse the MOMS Club Roster information as set forth in the MOMS Club Bylaws. (The Roster cannot be used for any type of commercial mailings, phone calls, or solicitations.)
6. Members shall abide by the Bylaws set forth by the International MOMS Club.
7. Members shall abide by the Facebook group policies set forth by our chapter.

Action may be taken against any member who violates this Code of Conduct. The actions will be as follows:

- A. First Offense: verbal warning
- B. Second Offense: written warning
- C. Third Offense: member will be asked to leave the MOMS Club and their dues will be forfeited.

- Any member planning to attend an event should RSVP to that event to allow for an appropriate headcount.

### General Reminders
